## *Are you a Company searching for Directors?*

Initiating a search is straightforward. Corporations and/or their Boards can confidentially submit requirements by going to our website, [www.nacdne.org](http://www.nacdne.org). A member of the Screening Committee will be assigned to contact you to discuss your needs and our process in more detail. The Screening Committee member will work with you throughout the process. Once your information is complete, the Screening Committee, comprised of experienced directors, will review our database for candidates that meet your criteria and forward their resumes.
